### **SCHOOL FEES AND GENERAL FINANCES**

At Westering High School, as a matter of policy and in keeping with the mission statement, the budget is based on maintaining and improving standards in all areas of the school's activities. The fundamental principle is that we are committed to giving all the children who attend Westering High School the best all-round education. We, therefore, need 100% support to maintain this principle through school fee payment.

#### **Debit Order / Cash Payments**

- (a) Debit orders must be signed annually. All parents who opt to use this method of payment must sign and return the debit order form to the bursar, Ms Van Giesbergen, by **30 November 2023**. (Completed debit orders may be emailed to [bursar@westeringhigh.co.za](mailto:bursar@westeringhigh.co.za) or hand delivered to the school). Fees will be deducted as follows:  
over 10 MONTHS from 1 Feb. – 1 Nov. or 20 Feb. – 20 Nov.
- (b) Bank charges will be for your account each time your debit order is rejected.

#### **Once-off Cash**

If paid by 28 February, the annual fee is reduced.

#### **Debit/Credit Cards**

The school offers a debit/credit card facility. No Diners Club cards accepted.

#### **Who pays the fees?**

- (a) In terms of Family Law, parents are jointly and severally liable for the payment of a learner's school fees.
- (b) In the event of non-payment, action will be taken against BOTH parents regardless of any maintenance agreements which may exist between the parties.

#### **Legal Action**

- (a) **Fees are payable in advance for the year** and, therefore, will be handed over to our debt collectors immediately if the first instalment is not paid on due date.
- (b) **NO fees will be carried over into the following year. Balance as at 30 Nov. will be handed over by 30 Nov. at 9am.**
- (c) Statements will be sent out each month.
